although post structuralism has highlighted the importance of what is offstage lost forgotten hidden or discarded silent or silenced the poetics and politics of absence much like its ethics and aesthetics have rarely been discussed across media or disciplines the book conceptualizes radical absence to describe a certain tradition of resistance to ontology predication and representation contesting their reliance on a metaphysics of presence apophatic speech empty signifiers and figural voids are some of the figures through which radical absence becomes apparent with unprecedented intensity in 20th century theory literature film and the arts phantasmatic and outrageous such figures play with creative strategies of de materialization irony and other forms of discursive undoing therefore absence becomes more than a simple theme it reflects back on the medium and the meaning making conditions under which it operates elusive and imprecise as an object of study absence is in need of more subtle and flexible epistemological frameworks the author proposes to think it not only as a counter concept for presence but also perhaps more productively as infinite spacing deferral fragmentation and displacement

the number of catholic communities with no priest available to celebrate sunday eucharist has increased steadily over 60 years for many other forms of sunday celebration are the statistical norm this dramatic development coincides with vatican ii's insistence on liturgical catechesis for the baptised the main source of their christian spirit comes from active participation in the liturgy especially the sunday eucharist celebrating the liturgy in all its symbolic fullness leads to inner participation in the mystery a more profound appropriation of this living relationship with christ comes about through well celebrated rites and reflection on personal experience of the rites yet liturgical catechesis is largely ignored or dismissed because it is not understood liturgical celebrations frequently lack the vitality capable of leading people into the depth of the sacred mysteries they celebrate sunday celebrations in the absence of a priest are no exception this book presents a systematic treatment of the modern church's teaching on liturgical catechesis it proposes ten general principles of liturgical catechesis these principles are used to explore and criticize the directory for sunday celebrations in the absence of a priest 1988 as well as the rituals prepared from the directory by the usa and canada even when there can be no sunday mass in parishes hospitals and nursing homes navy ships and jails liturgical prayer is to be a privileged place of evangelisation catechesis spirituality and discipleship in christ

it's silence soundly it's nothing seriously and it's absence presently continue the it series published by matador since the book of it 2010 they constitute another stage in an artistic journey exploring the visual and audial dialectic of mark word and image that began over 25 years ago in their aesthetic form the books are a decentred trilogy united together in a new concept of the bibliograph all three present this new aesthetic object which transcends the narrow limits of the academic bibliography the alphabetical works also share a tripartite structure and identical length the bibliograph itself is characterised by its strategic place within each book as a whole as well as by the complex variations in meaning of the dominant motifs nothingness absence and silence which recur throughout the alphabetical entries that constitute the elements of each text it's nothing seriously for example addresses the amusing paradox that so much continues to be written today about nothing the aleatory character of the entries in the texts encourage the modern reader to reflect on each theme and to read them in a new way the reader is invited as well to examine their various intertextual relations across

during the past century an enormous effervescence of events changed the sociopolitical configuration of the world the interpretation of these facts helped further deepen the crisis in which modern thought already found itself and it generated the uncertain and unstable environment in which we live today the so called postmodernity late modernity or hypermodernity in this context one of the most profound impacts is most certainly the one on religion during the twentieth century religion proved not to be banished from the human horizon as the masters of suspicion intended known as the godless century the twentieth century saw also a resuscitation of the search for the sense of life and spirituality with the crisis of modern reason humankind turned toward consumerism and provisional and light practices the last century represents not only the height of the postmodernization process but also the rescue of the transcendent and absolute even if it is an absolute without face and identity it is in this scenario that religious experiences apparently exiled by modern rationality begin to occur and multiply again mystical experiences will be then the basis for highlighting recurrent characteristics with universal import but they will show a different configuration than before one will be able to find them not in so called sacred spaces but in very secular ones not so much within institutions but at the borders or even outside them not configured by a specific tradition but in an interface that makes more than one tradition meet and dialogue
